### Privacy Policy

#### Privacy

This privacy policy applies only to information collected online through the Sioux City Country Club's website, software, and mobile applications, and not to information collected offline. The Sioux City Country Club's website, software, and mobile applications are not intended for use by a person in any state or country where such use would be contrary to local laws or regulations.

This privacy policy is subject to change without notice. When changes are made, we will revise the "modified" date at the top of this policy. We encourage you to visit this page periodically so that you are aware of the most recent privacy terms. This privacy policy reflects the Sioux City Country Club's current practices.

By using our sites, software, or mobile applications you acknowledge that any information provided by you is provided voluntarily and is subject to this privacy policy, to which you consent.

#### Information Collection and Use

We collect information from you when you use our web-based tools, when you subscribe to certain services, when you follow posts and comments, or fill out a form.

When communicating with us through our websites, software, or mobile applications for these purposes you may be asked to enter your name, email address, mailing address, phone number, membership account number, username and password, or any other identifier that allows us to contact you.

Any of the information we collect from you may be used in any of the following ways:

- To facilitate our services to members;
- To administer our business;
- To improve our website or mobile applications based on the information and feedback we receive from you;
- To contact or update you regarding member services, events, and promotions;
- To respond to your service requests and support needs;
- To evaluate the effectiveness of any marketing materials; or
- To respond to your posts or submissions.

You may send us personal information in an email or in an online form. We will use this information to respond to your requests and may forward it to others who are better able to answer your inquiry.

**Information from Children:** It is our policy not to collect electronic information from minors and more specifically from children under the age of 13. Persons under the age of 13 should not

send any individually identifying information to us unless we have first received their parent's or legal guardian's signed consent.

### **Information Sharing and Disclosure**

Except as explained below, we do not sell, rent, trade, or otherwise transfer to third parties your personally identifiable information. The exception is where the information is shared, provided to or accessed by trusted parties who assist us in operating our website, or in responding to your requests for service. We may provide information to trusted parties, such as our business partners, in compliance with our privacy policy and confidentiality and security requirements. We may also release your information when we believe it is appropriate to comply with the law, enforce our site policies, or protect ours or others' rights, property, or safety.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through the Sioux City Country Club social media sites (such as via public message boards) you do so at your own risk and this information may be viewed, collected and used by others.

### **Security of your Personal Information**

Although no system can be completely secure, the Sioux City Country Club utilizes commercially prudent business procedures such as secured networks, to guard your personal information from unauthorized access, use or disclosure. You should not send private or sensitive information to us by e-mail or via our website or mobile application.

### **Use of "Cookies."**

Cookies are small files that a site or its service provider uses via your web browser or mobile phone (if you allow) to enable the systems to recognize your browser and capture and remember certain information. We may use cookies to aggregate data about site traffic and site interactions in order to offer a better user experience. Third parties, such as Google Analytics, may be used to track such information on our behalf. The data is in the form of aggregated, anonymous information and no personal information is exchanged via cookies.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of our services or the websites you visit. We do not collect or store any personal information that you provide to us in your cookies.

### **Analytics**

We may use Search Engine Optimization (SEO) tools such as Google Analytics to help analyze how visitors use our sites and applications. Such analytics use de-identified data such as "cookies," to collect standard internet log information and visitor behavior information in an anonymous form. The anonymous information generated by the cookie about your use of the website or mobile application (including your IP address) is then used to evaluate aggregate use of the website or mobile application and to compile statistical reports for the Sioux City Country Club.

We do not use these tools to track or to collect any personally identifiable information. We will not associate any data gathered from this site with any personally identifiable information from

any source, unless you explicitly submit that information via a fill-in form on our website or through our mobile application. By using the Sioux City Country Club website or mobile application, you consent to the processing of data about you by Google Analytics or other SEO providers in the manner described above.
